Ramona Town Board

The Ramona Town Board met Tuesday, Mar 13, 2023 at 6:00 pm in the Ramona Community Building with members Larry Malcomb, Tony Fischer and Lisa Beyer (via phone) present. Also present Elizabeth Whitethorn, and Maren Fischer.

Meeting was called to order. Previous meeting minutes were read. Motion by Beyer, seconded by Fischer to approve as read.
