Ramona Town Board

The Ramona Town Board met Tues. May 12, 2026, at 6:00 pm in the Ramona Community Building with members Tony Fischer, Robert Sechser, and community members present.

All motions passed unanimously unless otherwise stated.

Meeting was called to order. Previous meeting minutes were read. Motion by Fischer, seconded by Sechser to approve as read.

Community members asked about grant funds/annual report, water for the school, Kingbrook project, refund of utility service deposits, and tree branches hanging over the road.

Bar business was discussed.

The water loan with Rural Development was discussed.

Reading of Resolution 107-26, Flood Hazards. Motion by Fischer, seconded by Sechser to adopt Resolution 107-26.
