Ramona Town Board

The Ramona Town Board met Tuesday October 8, 2024, at 6:00 pm in the Ramona Community Building with members Larry Malcomb, Lisa Beyer, and Tony Fischer present.

Meeting was called to order. Previous meeting minutes were read. Motion by Beyer, seconded by Malcomb to approve minutes as read.

Reading of resolution 101-24, a resolution to allow the municipality to impose a tax on the sale, use, storage, and consumption of items that conform in all respects to the state tax on such items up to two percent, should IM-28 pass on November 5, 2024. 3 votes yea, 0 nay.

Reading of resolution 102-24, authorizing the bar to be open on Sundays beginning October 19, 2024, through and including December 29, 2024. 3 votes yea, 0 nay.
